In continuation to the notification dated 18.12.2021 and subsequent notification(s), the mop-up round 2 (off-line) allotment procedure for BDS for Rajasthan State registered candidates, will be carried out off-line as per the schedule given below:

It is a mandatory step for subsequent process of registration and allotment. Both the parts (Part 1 and Part 2) of the application form must be filled and completed. Candidates who could not complete both the parts (Part 1 and Part 2) of the application form earlier, may also complete the same.	08.05.2022 to 10.05.2022 by 11.45 pm
2.	Last date for deposition of the application fee, on-line, (including by candidates who have not deposited it earlier)	10.05.2022 by 4.00 pm

5.	Publishing of provisional Merit list (for mop-up round 2)	11.05.2022

8.	<b>Stray vacancy round: Residual seats allotments in Private Dental Colleges</b> The list of registered candidates eligible for residual seats will be provided to the concerned colleges Seats remaining vacant in private dental colleges to be filled at the level of concerned dental college <b>For admission on residual seats of private dental colleges, candidates are required to contact the concerned dental college directly</b>	15.05.2022, 10.00 am

Residual seats - Physical Reporting, document checking and verification (including prescribed eligibility criteria) <b>at concerned Private Dental College</b> along with deposition of fee prescribed by the college, required bonds etc. and other documents as listed in instruction booklet	15.05.2022

1. Refer information booklet, college information sheet and college fee structure etc. and other information at the website.
2. The candidates are advised to visit the websites regularly for registration and other relevant information.
3. All registered candidates who wish to participate in off-line mop up round 2 must present themselves personally before the Board on the stipulated date and time.
4. Submission of original documents: All candidates who wish to participate in off-line mop up round 2 must bring all the original documents and undertaking as given in the instruction booklet available at the website.
5. The candidates having other eligibility criteria as XI shall be considered for allotment in mop-up round 2 after exhausting the candidates having eligibility criteria between I to X.
6. A candidate who has already joined a seat allotted through Rajasthan state counseling /any other state counseling including all India counseling shall not be eligible to participate in mop up round 2.
